

Participant Waiver and Release of Liability

READ BEFORE SIGNING

In consideration of being allowed to participate in any way in events sanctioned by the RollerSoccer United States Alliance (RSUSA) and related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I understand safety equipment such as headgear is required by the RSUSA and other protective gear. I understand that I am fully responsible for the condition of my skating equipment; and,
3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
4. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participations and bring such to the attention of the nearest official immediately; and,
5. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS the RollerSoccer United States Alliance (RSUSA), the cities where events are conducted, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors advertisers, and owners and lessors of premises used to conduct the event ("Releases"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE; and,

I understand that I may be filmed, taped, or photographed as part of RSUSA events and that my image, likeness, and voice may be broadcast, displayed, shown, projected, reproduced, or otherwise used by third parties. I authorize this filming, taping, photographing and other use and understand that I have NO RIGHT OR INTEREST IN THE RESULTING FOOTAGE or in any program or other display utilizing such footage in any media whatsoever.
